

ESTREPTOPENICILINA MICROSULES

Broad spectrum antibiotic



Formula

Each 1 ml contains:

Penicillin G Procaine.....200,000 UI
(200,000 UI Penicillin G Procaine equivalent to 200 mg Penicillin G)
Dihydrostreptomycin sulphate.....314 mg
(equivalent to Dihydrostreptomycin sulfate 250 mg)
Procaine hydrochloride.....20 mg
Excipients q.s.ad.....1 ml

Indications

Estreptopenicilina Microsules is indicated for the control and treatment of infections of the respiratory, urinary, gastrointestinal and reproductive systems, mammary gland, skin, etc.

Spectrum of action: *Staphylococcus aureus*, *Streptococcus beta-hemolítico*, *Streptococcus spp.*, *Haemophilus spp.*, *Proteus spp.*, *Shigella spp.*, *Salmonella spp.*, *Escherichia coli*, *Pasteurella spp.*, *Pseudomona spp.*, *Klebsiella spp.*, *Campylobacter fetus*, *Leptospira spp.*, *Brucella spp.*, *Clostridium spp.*, *Bacillus spp.*, etc.

Target species

Bovines, ovines, equines, dogs, cats.

Route of administration

Parenteral administration, intramuscular injection.
Shake well before administering.

Dosage

Recommended doses:

Large animals: 5 ml per 100 kg weight daily.

Small animals: 1 ml per 10 kg weight. Treatment duration: 3 to 5 days or according to Veterinarian's discretion.

Withdrawal period

Meat: do not slaughter treated animals for human consumption, before 30 days from last treatment.

Milk: do not use in lactating animals whose milk is intended for human consumption, 96 hours before delivery.

Precautions

Do not reuse empty containers. Dispose of remainder and containers safely, either by burning or by burying them far from rivers, lakes, springs, etc. Keep out of the reach of children and domestic animals.

Store in a fresh and dry place; away from sunlight and between 5 and 25°C.
